An instrument of gift for these papers was signed by General Cannon in April 1975. Literary property rights are retained by the donor until his death. At that time such rights pass to the United States. Under terms of the instrument of gift the following classes of documents are withheld from research use:

1. Papers relating to the Cannon and/or Eisenhower family business affairs.
2. Papers relating to the family and private business affairs of other persons who have had correspondence with General Cannon.
3. Papers relating to investigations of individuals or to appointments and personnel matters.
4. Papers containing statements made by or to General Cannon in confidence unless in the judgment of the Director of the Dwight D. Eisenhower Library the reason for the confidentiality no longer exists.
5. All other papers which contain information or statements that might be used to injure, harass, or damage any living person, including first generation heirs thereof.

## SCOPE AND CONTENT NOTE

The personal papers of General C. Craig Cannon cover the period from 1945 to 1954. The bulk of the collection consists of correspondence between General Cannon and Milton Eisenhower, Arthur Eisenhower, Edgar Eisenhower, Secretary of Defense Louis Johnson, Amon Carter, and William Robinson. Most of the correspondence with Robinson pertains to General Eisenhower's campaign for the Republican Presidential nomination. Also included within the collection are transcripts, speeches, lists, and drafts of letters by Cannon for General Eisenhower with DDE's editing notations.

The collection is arranged chronologically by date of the document.
