These papers were reviewed under terms of the instrument of gift executed by Dwight D. Eisenhower on April 13, 1960. Under terms of this instrument, the following classes of documents are withheld from research use:

1. Papers that are security-classified.
2. Papers the use of which may be prejudicial to the maintenance of good relations with foreign nations.
3. Papers containing statements made in confidence unless in the opinion of the Director of the Dwight D. Eisenhower Library the reason for confidentiality no longer exists.
4. Papers relating to family or private business matters.
5. Papers containing statements about individuals which might be used to injure or harass them or members of their families.

SCOPE AND CONTENT NOTE

The Papers of Harris Ellsworth focus on the period during which he served as Chairman of the United States Civil Service Commission. The personal correspondence within the collection contains a few scattered comments on Oregon politics, but otherwise pertains solely to family matters. The remainder of the collection consists of memos, letters, speeches, reports, and newspaper clippings concerning the Civil Service Commission.

The most substantive material in this category relates to pay scales for federal employees. Only a few scattered items in the collection pertain to Ellsworth's tenure as a congressman from Oregon.
