Literary rights in the records have passed to the United States as indicated in President Eisenhower's letter of April 13, 1960. As indicated in Eisenhower's letter, the following classes of documents will be withheld from research use:

1. Papers that are security classified pursuant to law or Executive Order, until such classification shall be removed.
2. Papers the use of which may be prejudicial to the maintenance of good relations with foreign nations.
3. Papers containing statements made by or to me in confidence.
4. Papers relating to my family or private business affairs, and papers relating to the families or private business affairs of persons who have had correspondence with me.
5. Papers containing statements about individuals which might be used to injure or harass them or members of their families.
6. Such other individual files as I, or my representative, or the Administrator of General Services may specify.

## SCOPE AND CONTENT NOTE

The White House Library is a collection of reference material kept at the White House for use by the President and his staff. Most of the material consists of books donated to the White House by publishers, or loaned to the White House by the Library of Congress. The collection is maintained by the permanent White House staff under the direction of the Executive Clerk.

During the 1970s the White House Library turned over to the National Archives a number of surplus reports and printed items which were no longer needed by the White House. The National Archives forwarded to the Eisenhower Library the material that pertained to the Eisenhower administration. Most of the material consists of reports of various government committees and boards, many of which can be found elsewhere in the Eisenhower Library. The material is arranged alphabetically by subject.

Of particular importance is a file on form letters used by the White House staff. This consists of sample paragraphs that assisted secretaries in preparing letters to the general public. The file also contains samples of preprinted cards that were used to acknowledge messages from the public. The cards were prepared in advance of a major event, such as Christmas or the President's birthday, for which mail was expected in such large quantities that the White House did not have sufficient staff to write individual responses.
