An instrument of gift for these papers was signed by Mr. Hanes in March 1981. Literary property rights to the donor's unpublished materials have been assigned to the United States of America. Under terms of the instrument of gift the following classes of documents are withheld from research use:

1. Papers and other historical materials that are specifically authorized under criteria established by statute or Executive Order to be kept secret in the interest of national defense or foreign policy, and are in fact properly classified pursuant to such statute or Executive Order.
2. Papers and other historical materials the disclosure of which would constitute a clearly unwarranted invasion of personal privacy or a libel of a living person.

SCOPE AND CONTENT NOTE

John W. Hanes, Jr. began his government career with the State Department in 1950. After spending approximately one and one-half years as an economic analyst he transferred to the Central Intelligence Agency. He returned to the State Department when John Foster Dulles took the helm as Secretary of State and served in a series of administrative posts until the end of the Eisenhower administration when he resigned to enter private business.

The bulk of this collection documents Hanes' work in the State Department during the period 1953-1961. A second and fairly sizable body of material pertains to State Department related matters that were of continued interest to him after entering private life. Only a small amount of material deals with Hanes' government career prior to 1953.

The 1953-1961 material is of a personal and quasi-official nature. Hanes devoted time to supporting his alma mater, Deerfield Academy; pursued his interest in ornithology; and kept in touch with family, friends and acquaintances regarding personal and social matters as well as their inquiries and suggestions relating to his State Department work. Hanes occasionally corresponded with some of the many Foreign Service officers he had come into contact with throughout his career in the State Department. He served as somewhat of a mentor to junior Foreign Service officers and occasionally touched base with colleagues regarding overseas Foreign Service operations; the operation, organization and administration of the Foreign Service; and the state of affairs in other countries.

While serving in the State Department Hanes was involved in a variety of public relations activities including media interviews and speeches. He also provided congressional testimony on State Department issues, addressed professional conferences, did a small amount of writing, and served on committees and commissions within and on behalf of the State Department.

Hanes' activities as Deputy Assistant Secretary of State for International Organization Affairs are thinly documented. Documentation of his activities as Administrator, Bureau of Security and Consular Affairs, is richer but not extensive. The most substantive body of material is that pertaining to legislation relating to immigration and related matters. The trips Hanes made with Sec. Dulles to major international conferences are not documented. Documentation of minor conferences, other trips made by Hanes, and his involvement with Khrushchev's visit is thin.

Political material is somewhat limited. Hanes worked with the Task Force on Peace and National Security of the Republican Committee on Program and Progress and assisted in developing portions of the 1960 Republican Party platform dealing with foreign policy. Also, there is some documentation of the 1960 Republican National Convention.

Hanes had a close working relationship with Secretary Dulles. He handled special projects and assignments of a diverse nature for the Secretary, especially during the period 1953-1957 when serving as Special Assistant. In the mid-1950s Hanes worked with Dulles in developing plans for the disposition of Dulles' personal papers. As part of those activities Hanes was involved in drafting changes to Executive Order 10501 dealing with the safe-guarding of official information. After Dulles' death Hanes actively participated in administrative duties related to

the papers. He served as a member of the committee which Dulles designated for the purpose of exercising control over his papers after his death.

The material pertaining to Hanes' work on Dulles' papers committee constitutes the bulk of the material dated after Hanes left the State Department in 1961. Also dating after 1961 is material documenting Hanes' interest in the immigration legislation that Congress passed in the mid-1960s. As evidenced by this collection, Hanes kept a reference file on the topic but did not play an active role in developing the legislation.

It appears as though portions of the file "Cabinet Papers" were maintained originally by M. Phleger of the Legal Division of the State Department and were then turned over to Hanes for his retention. The series is arranged alphabetically by file title and in reverse chronological order therein.
