5. All other papers which contain information or statements that might be used to injure, harass, or damage any living person.

DESCRIPTION

The personal papers of John Hubert Else consist of a few letters, programs, booklets, newspaper clippings, certificates, army discharge papers, invitations, snapshots, photographs, notebook, and other materials. The papers are arranged alphabetically by subject. This file was received unarranged. Papers were placed in folders with titles devised by a staff member.

Subjects covered in the early period of the file refer to Mr. Else's activities at the University of Kansas, where he was a student for the period 1925-1932, graduating from the School of Law in 1932. Later portions of the file deal with his army career in World War II; his works as an administrative assistant for Senators Reed, Darby, and Carlson, of Kansas; his service as an advisor to both the Federal Housing Administration (1958) and the Housing and Home Finance Agency (1959); his affiliation (1951-1965) as National Affairs Counsel of the National Retail Lumber Dealers Association, personal friends, and others.

BIOGRAPHICAL NOTE

John Hubert Else graduated from the University of Kansas Law School in 1932; thereafter, he engaged in the practice of law. He served in the Army during World War II and was honorably discharged in 1945. In early 1946 he went to Washington, D.C. and began serving as administrative assistant to Senator Harry Darby (R.-Kan.), Senator Reed's successor; and later he was briefly on the staff of Senator Frank Carlson (R.-Kan.).

In 1951 Mr. Else became National Affairs Counsel of the National Retail Lumber Dealers Association, retiring from that post in 1965. He then became associated with the National Association of Manpower Councils. He died December 22, 1968.
