The records of Wayne B. Warrington, Special Assistant in the White House Office, were received at the Library with other White House records shortly after the end of the Eisenhower Administration.

The Warrington records were reviewed according to the terms of Dwight D. Eisenhower's letter of gift to the Administrator of General Services dated April 13, 1960. According to those terms, the following materials were to be withheld from research:

1. Papers that are security-classified pursuant to law or Executive Order, until such classification shall be removed.
2. Papers the use of which may be prejudicial to the maintenance of good relations with foreign nations.
3. Papers containing statements may by or to the President in confidence.
4. Papers relating to the President's family or private business affairs, and papers relating to the families or private business affairs of persons who have corresponded with the President.
5. Papers containing statements about individuals which might be used to injure or harass them or members of their families.

SCOPE AND CONTENT NOTE

Wayne B. Warrington began his public service in 1953 when he joined the Arizona State Highway Department, where he worked on promoting traffic safety. In 1954, Arizona Governor Howard Pyle appointed Warrington state Commissioner of Public Welfare. In 1956, he moved to Washington, D.C., as Director of the Veterans Division of the Republican National Committee. In February 1957, Warrington rejoined his former boss, Howard Pyle, in the Eisenhower White House, where Pyle served as Special Assistant to the President for Intergovernmental Relations. Warrington left the White House in May 1959.

This collection contains material relating primarily to Federal-State relations and includes correspondence, reports, addresses and miscellaneous printed material concerning such topics as Federal aid to education, taxation, the Atomic Energy Commission's relations with the states, national Governors' Conferences in 1957 and 1958, and other matters pertaining to Federal-State relations. Included are reports of the American Council on State Governments, the American Municipal Association and Governors' Conferences; as well as news clippings on Hell's Canyon; and speeches by President Eisenhower, Richard Nixon and other administration officials.

The first three boxes contain reports, pamphlets, summaries, etc., relating mainly to general federal-state relations matters, such as aid to education and fiscal matters. Box 4 contains, in addition to general material, proposals, statements, and resolutions prepared at the Governors' Conferences held in Williamsburg, Virginia, in 1957 and at Bal Harbor, Florida, in 1958. Box 5 contains drafts of the President's address at the 1957 Williamsburg conference. Box 5 also contains materials concerning natural resources, liens on motor vehicles, and many other issues. Box 6 contains summaries of the Administration's power policy in general and on Hell's Canyon Dam in particular. Also, researchers will find here, editorial opinion on Hell's Canyon. Box 6 also contains material pertaining to the Hoover Commission and to unemployment compensation. Box 7 consists mainly of correspondence relating to urban policies, and Warrington's personal correspondence.
